## **RE., A letter of support**

To whom it may concern,

I am writing to acknowledge and support Port Pirie Regional Council and its bid to secure a financial contribution from the Federal Government to replace the existing derelict Port Pirie Fisherman's jetty with a much-improved facility.

The Port Pirie Fisherman's jetty was constructed in 1926 for both commercial and recreational use. Today, it is aged, structurally unsafe and unsightly. It is in desperate need of renewal, is load limited to vessels under 6m, and needs to be replaced with a modern, safe floating pontoon marina structure.

The facility is closed for recreational use to the public and only a small number of moorings are being utilised, and the jetty requires extensive repairs and maintenance. There is, however, demand for larger boats and additional moorings.

Council is keen to build back better with a project in line with the objectives of the SA Boating Facility Strategic Plan which includes activating boating destinations, connecting boating routes and improving amenity, accessibility and safety. This infrastructure project will complement the existing Solomontown boat ramp and precinct, that was substantially upgraded a few years ago.

The Port Pirie Fisherman's jetty upgrade project will create jobs, a waterfront destination with benefits in tourism - including river eco-tourism, the marine cruising sector, fishing charters, and the hospitality industry with increased visitation.

It is understood that Council estimates the project cost as \$5.4M with the Council contributing \$2.7M.

Council's Port Pirie Fisherman's jetty project will provide in Stage 1, 5 x 6m berths, 17 x 9m berths, 10 x 12m berths, 1 x 24m berth totalling 33 - eventually with the completion of Stage 3 - 71 moorings.

This activation will encourage water-based activities and provide a much-needed modern marina supporting safe, convenient and accessible facilities for people of all ages and abilities.
